RESOLUTION NO. 296-2023

RESOLUTION AWARDING A CONTRACT FOR THE DESIGN AND REPLACEMENT OF THE TRAFFIC SIGNALS AT THE INTERSECTION OF BERDAN AVENUE AND PLAZA ROAD TO ZUCCARO, INC.

WHEREAS, the Borough of Fair Lawn (the "Borough") duly advertised for bids to be received on July 19, 2023 for the Design and Replacement of the Traffic Signals at the Intersection of Berdan Avenue and Plaza Road; and

WHEREAS, the Borough received one (1) bid as set forth on Exhibit A, Bid Summary Sheet, attached hereto; and

WHEREAS, the bid was referred to the Borough Manager and appropriate Department Head for review and recommendation; and

WHEREAS, Zuccaro, Inc., having an office located at 64 Commerce Street, Garfield, New Jersey 07026, is the lowest responsible bidder in accordance with the attached Exhibit A,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Fair Lawn that, upon recommendation of the Borough Manager and appropriate Department Head, the Design and Replacement of the Traffic Signals at the Intersection of Berdan Avenue and Plaza Road bid be awarded to Zuccaro, Inc., in a total amount of \$512,313 with a project allowance of \$50,000, per the attached Exhibit A; and

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Fair Lawn have allocated funds in the Budget Accounts C-04-22-615-295-400, C-04-23-667-295-101, and pursuant to N.J.A.C. 5:30-5.4, a Certificate of Availability of Funds has been completed by the Chief Financial Officer through the issuance of Purchase Order #23-01649; and

BE IT FURTHER RESOLVED, that the Mayor and Borough Clerk are hereby authorized to enter into a contract with Zuccaro, Inc., 64 Commerce Street, Garfield, New Jersey 07026 for the Design and Replacement of the Traffic Signals at the Intersection of Berdan Avenue and Plaza Road, at a total cost of \$512,313 with a project allowance of \$50,000.
