Current Fire Safety Advisories:

18-01 Pollitt Dr., Private hydrant damaged and out of service.

22-18 to 22-26 Maple Ave., Vacant strip mall of non-combustible type construction. Portions of the floor are being excavated leaving open pits inside the building. The Fire Alarm and Automatic Sprinkler Systems are out of service. Utilities have been de-activated.

3 Kossuth Pl., Single family Residence, of wood frame construction. Excessive obstructions make passage extremely difficult inside the home, conditions are such that interior firefighting and rescue would be extremely difficult.
